WestCare Arizona offers a Domestic Violence Shelter for women and children fleeing harmful/unstable environments. Our 20-bed licensed domestic violence shelter offers 24-hour crisis intervention, support groups, legal and community referrals, and employment assistance. Staff assists victims in transitioning to a safe living environment while rebuilding their lives. Additionally, WestCare provides court-ordered treatment for defendants arrested for domestic violence. Defendants are educated on the causes of abusive behavior and family violence and intimate partner violence; the effects violent behavior and abusers have on a victim; and changes that must occur to prevent repeat domestic violence offenses and law enforcement domestic violence intervention. The referring courts are apprised of their progress and completion.

WestCare's Youth Prevention services provide in-school and online video-based classes utilizing an evidence-based curriculum, providing prevention and life skills in today's world. Life skills parenting classes guide parents and caregivers to learn the signs and effects of substance abuse. Arizona offers court-ordered DUI screenings, assessments, education, and treatment. For DUI, we follow the Arizona DUI Statutes for the level of education and/or treatment needed, which is determined by the screening.
