WestCare received a grant to provide a program for youth and adolescents funded through the

Department of Health and Human Services, Center for Disease Control, National Center for Injury Prevention and Control. The program's objectives will meet one of the focus areas of the Department of Health and Human Services: Healthy People 2010 – Injury and Violence Prevention. This new program is called Children Developing Creatively

(CDC). With this grant, WestCare Arizona has the opportunity to provide the CDC program at no cost to the participants, including transportation for those who request it. Additionally, incentives for participants and their parent(s)/guardian(s) will be offered.

CDC will offer groups that educate youth ages 6–17. These eight- to tenweek groups will promote pro-social behaviors such as anger management, problem solving and conflict resolution skills, as well as address the

importance of communication to anti-bullying and anti-violence ideologies.

m estCare}$ California opened the doors January 4, 2009 to their new WestCare Center for Behavioral Studies (WCBS) in Fresno. WestCare wants to encourage staff to continue their personal growth and education in the field of drug and alcohol counseling to better support the clients we serve. Searching for the best certification option, WCBS sought approval of the curriculum from the California Association of Alcoholism and Drug Abuse Counselors (CAADAC), one of the highest levels of certification in the state. WCBS is proud to offer three levels of education approved for CAADAC certification: Certified Alcohol and Drug Counselor Associate (CADCA), Certified Alcohol and Drug Counselor I (CADC I) and Certified Alcohol and Drug Counselor II (CADC II).

Classes will be offered in three different sections to accommodate staff work schedules. These tracks

include Friday/Saturday classes, evening classes and morning classes. Each track lasts nine months

and covers several areas of study, such as "Specific Mental Disorders and Cross-Cutting Issues" and "Disease Concept and Addiction Theories."

One of the best parts of WCBS is that tuition is free to any employee of WestCare, with the exception of books and CAADAC fees. Members of the general public have also taken notice of WCBS, as have our colleagues from other service agencies. Classes are open to those who are not employed by WestCare, but they are charged the full tuition rate.

Since the enrollment of WestCare employees into WCBS is limited to those within driving distance to the campus, it is hoped that courses will soon become accessible via the Internet. "I am impressed with this fantastic and unique opportunity that WestCare is offering to its

employees," said Robert Yancey, Ph.D. instructor of the program at WCBS. "I hope that all WestCare employees across the country will soon have the option of attending."

WestCare Georgia Partners with the Georgia State Board of Pardons and Paroles By Dottie Thomas

WestCare Georgia recently entered into a partnership with the Georgia State Board of Pardons and Paroles to provide Adult Methamphetamine Outpatient Services to parolees in DeKalb County and Richmond County, Georgia. These services are provided at no cost to the clients and are funded by the Georgia Department of Human Services, Division of Mental Health, Developmental Disabilities and Addictive Diseases.

Dottie Thomas (CACII), lead substance abuse counselor, was instrumental in developing the

partnership with the Board of Pardons and Paroles. Dottie and Jeannie Lewis, program director, met with Marta Daniell, manager of Georgia State Board of Pardons and Paroles, and Cynthia Sneed, administrator of DeKalb Parole Center, to introduce the Atlanta Meth Intensive Outpatient Program model that resulted in approval to provide off-site meth treatment at the Parole Center. During this meeting, Marta Daniell stated, "Thanks so much for your efforts in establishing this valuable program in our district. I am impressed with the information received from WestCare's staff."

Cynthia Sneed, DeKalb County Parole and Pardons administrator later wrote, "I really enjoyed meeting you guys yesterday. We appreciate your willingness to provide services to our parolees in the DeKalb district. There is a great need for intensive services for our population." The Atlanta meth team established a schedule and began the first IOP group on January 8, 2009.

WestCare is excited with this new relationship and the possibility to provide IOP services statewide for the Georgia Board of Pardons and Paroles.

Southwest Texas Chili from The Mustard Seed Inn

Ingredients:

- 2 Pounds Ground Grilled Pork
- 2 Pounds Ground Grilled Shirt Steak
- 3 Large Yellow Onions Diced
- 1 Green Bell Pepper Diced
- 1 Red Bell Pepper Diced
- 10 lb. Box Pulled Chicken
- 3 Cups of Chili Powder
- ½ Cup Cumin
- ½ Cup Fresh Garlic
- 1/4 Tablespoon Crushed Red Pepper
- 1/4 Tablespoon Garlic Powder
- 3 Cups Chicken Base
- 2 Cans #10 Kidney Beans
- ½ Cup Sugar
- 1/4 Cup Salt
- 2 TBS Black Pepper
- 2 Large Cans of Tomato Paste
- 1 Cup of Flour

Directions:

- Mix well all the meat in a large pot and brown.
 (Cut open all meat casings and squeeze out)
- 2. Mix well until done.
- 3. Add tomato sauce and all the seasonings.
- 4. Cook over low to medium heat for 30 min. stirring occasionally to avoid sticking.
- 5. Then reduce heat to low and cover and cook 1 hour more.
- 6. Stir occasionally.
- 7. Sample, sample and sample.
- 8. Add more of whatever you think it needs (you make the call).
- 9. Turn heart off and let cool.
- 10. Place in the refrigerator over night (yep over night).
- 11. Reheat the next day and serve it your way!

Up Close and Personal


Dwight Howard, Jr.

Dwight D. Howard, Jr. was born in Atlanta and became the first player in NBA history to start in all 82 games during his rookie season directly out of high school.

As an early entry candidate in the 2004 NBA Draft, Dwight was chosen number one overall by the Orlando Magic. Dwight was a unanimous selection to the NBA's All-Rookie First Team and finished third in voting for NBA Rookie of the Year. He averaged 12 points per game and is one of only eight players in the NBA to average a double-double and the first rookie (along with Charlotte's Emeka Okafor) to average a double-double

since Shaquille O'Neal and Alonzo Mourning accomplished the feat in 1992–93.

When he's home in Atlanta, he attends the Fellowship of Faith Church, International in East Point, Georgia. Dwight is still involved and active with the youth programs at the church. Children and family relationships are very important to him. Dwight believes that without the Lord in your life, you cannot fulfill your dreams.

Dwight David Howard is the fifth of seven children born to the late Reverend Paul Howard, Sr. and. Gussie Howard. Dwight's early life was spent in the rural South Georgia town of Midville. At the age of 13, the family moved to Swainsboro, Georgia. Two great things happened in Swainsboro: Dwight graduated from Swainsboro High School after having three great basketball seasons, and he met his wife, Sheryl.

After graduation, Howard moved to Atlanta where he attended one year at Morehouse College and three years at Georgia State University. After college, Dwight began a 21-year stint in law enforcement, beginning as a corrections officer for the City of Atlanta. After six years, he became one of Georgia's first Georgia State Patrol officers in which he served for 15 years.

During this same period of time, Howard followed his heart with a love for children and began his work as a coach at his church. He has coached track, football, baseball and basketball at his church.

Dwight is currently the athletic director at Southwest Atlanta Christian Academy in Atlanta and the executive director

of the Dwight D. Howard Foundation, Inc. He has been married to Sheryl for more than 27 years and has four children, David, Tashanda, Dwight, Jr. and Jahaziel. He also has two grandchildren, Tiara and Kareem, and will soon be the proud grandfather of a third grandchild.
